<p>1 In hearing your report provided to the CLC you were asked a question regarding the Seaborn Panel and their recommendations made regarding public consultation and how a referendum is ultimately the only fair and democratic way to determine whether we are a willing host. You appeared to have been unfamiliar with the findings of the panel so I have provided some links to their reports. In a nutshell the panel was the only government appointed body that did cross country hearings on the dgr concept (1995-98). Their conclusions were that the dgr concept on a scientific basis was acceptable but not on a social basis. (As you will no doubt hear in the coming months.) I have studied the panels reports since I was a councilor in 2012 when South Bruce entered the fray of learning along with 21 other municipalities. In that time I was also in correspondence with panel member Lois Wilson and read her book on the panel's proceedings. Nuclear Waste: The Ethical Dilemma (Hard to find online but I have a copy if you're interested. I have to say I fully agree with the panel's recommendation regarding the ultimate decision should be done by a community referendum. However, I do agree with your methodology to seek a broad spectrum of input from our community.</p> <p>However I adamantly disagree with your assertion that his council has the ultimate decision to make. I do not trust this council to make such a decision. Over the years of lobbying by the NWMO I have yet to hear any real critical analysis or comments made by them on the record. No one on council ran in the 2018 election on a platform to decide on our behalf whether we would enter a formal commitment to this proposal. Is there a survey, or perhaps a forthcoming survey?</p> <p>Secondly, the language in your 'Key Questions' section (page three) suggests to me that your project is a simply a maneuver on the part of South Bruce Council to sidestep the democratic process, viz. a binding referendum. It seems to imply that some opinions may carry more weight than others in deciding willingness, and more weight than an unwilling majority. Perhaps you could clarify your answers.</p>	<p>Thank you for your email and questions.</p> <p>You are correct, the survey is forthcoming and will be available on beginning on June 16 at the following link: https://southbruceswitchboard.ca/south-bruce-willingness-study</p> <p>To answer your question no opinions carry more weight than others in deciding willingness. the Municipality of South Bruce has retained GHD, as an independent and neutral community engagement consultant, to consult residents on how they would like willingness to be determined. A referendum is one of the ways willingness could be determined. Through this consultation process, residents will have the opportunity provide feedback on how willingness should be determined rather than having a particular method imposed on them. Other ways to determine willingness can include but is not limited to opinion polls, surveys, community engagement activities, community advisory committees, community panels or even a combination of these options listed.</p> <p>If your preference is for a referendum, we're interested in hearing that feedback and understanding why that's your preference.
