POSITION TITLE: Volunteer Firefighter

DEPARTMENT: South Bruce Fire Rescue Service SALARY GROUP: Fire Department

SUPERVISOR: Deputy Fire Chief

POSITION SUMMARY:

Perform fire-fighting duties and other related work as required. This is manual work of hazardous nature involving the fighting of fires, salvage, and rescue work and first aid generally under the direct supervision of Department Officers. Regular training and maintenance work of the fire station and equipment is required. Firefighters may be required to make decisions and work without supervision until an officer arrives at the scene.

GENERAL DUTIES/RESPONSIBILITIES:

Responds to fire, rescue, hazardous materials emergencies, and other emergencies assigned to his/her station.

MAJOR DUTIES/RESPONSIBILITIES:

- Lays and connects hose lines, nozzles, and other related appliances.
- Holds fire hoses and directs fire streams.
- Operates a pressure pump as assigned.
- Operates elevating devices as assigned.
- Drives fire apparatus as assigned.
- Carries, deploys, and climbs ladders.
- Operates rescue equipment.
- Performs salvage work at fire and emergency scenes using salvage covers, mops, squeegees, etc.
- Performs ventilation by making openings in buildings, using exhaust fans or fog streams.
- Enters burning or contaminated buildings, structures and other areas to perform rescues and/or fight fires while wearing required clothing and safety equipment.
- Provides first aid to the injured.
- Assists in cleaning and preparing fire-fighting equipment upon return to the station after an emergency call or a practice to in-service status.
- Attends regular training sessions to practice procedures and to learn firefighting and rescue methods.
- Cleans and maintains areas of the fire station used by the members as scheduled.
- Assists with fire prevention programs.
- Medical First Responder.
- Other duties as assigned by the Fire Chief, Deputy, or District Chief.

KNOWLEDGE AND SKILL:

During the probationary period, it is expected the firefighter will demonstrate and develop the following knowledge, skills and abilities;

- General knowledge of building construction
- General knowledge of equipment maintenance
- Technical knowledge of fire service apparatus and equipment
- Technical knowledge of operation and use of breathing apparatus
- Technical knowledge of first aid and CPR
- Technical knowledge of department policies, procedures and operational guidelines
- Technical knowledge of Town water distribution system, including the use and proper drainage of fire hydrants
- Technical knowledge of occupational health and safety rules and procedures (Section 21 guidelines)

QUALIFICATIONS:

- Proficient written and verbal communication skills
- Strong mechanical aptitude
- Must possess a DZ Driver's license or obtain a DZ within 2 years of employment. Must possess a valid Driver's license.
- Mental alertness, mechanical aptitude
- Must be able to attend Regular meetings and training
- Must possess or be willing/able to attain NFPA 1001 FF 1&2 Certification and Medical First Responder
- Ability to get along well with others
- Willingness to perform any task assigned

HOURS OF WORK: Infrequent hours as required

- Conscientious and dependable
- Good physical condition

CONDITIONS OF EMPLOYMENT:

The firefighter will be expected to respond and work in all types of weather and in less-than-ideal conditions. He/she could have to enter hazardous atmospheres and areas and will be expected to work in a safe manner - in accordance with all applicable Acts, Regulations, and Policies.

Must be able to provide a clear Vulnerable Sectors and Police check as well as an acceptable Drivers abstract.
